

(2) **Ordinary Trustees:** A person who may be co-opted as Trustee for a particular period is called as ordinary Trustee. They are temporary Trustees.

(3) **Office Bearer of Trustees:** Office bearer who are elected as such by and among the life Trustees.

(4) **Voting Powers:** Only life trustees have the voting powers and other forms of trustees have no voting powers.

(5) **Vacancy:** (a) If there were to be any vacancy in the category of life trustees either due to demise or resignations or due to any other reasons, Board of Trustees is empowered to co-opt the nominee or a legal heir of the demised trustee in his place as Trustee. Such Trustee shall be a Trustee for life.

(b) If there were to be any vacancy in the category of ordinary trustees either due to demise or resignation or due to expiry of term or due to any other reasons, Board of Trustees is empowered to co-opt a new Trustee in his place. (10) **Minutes:** A minute book shall be maintained by the Board of Trustees.
